**Summary of Investment Objective**

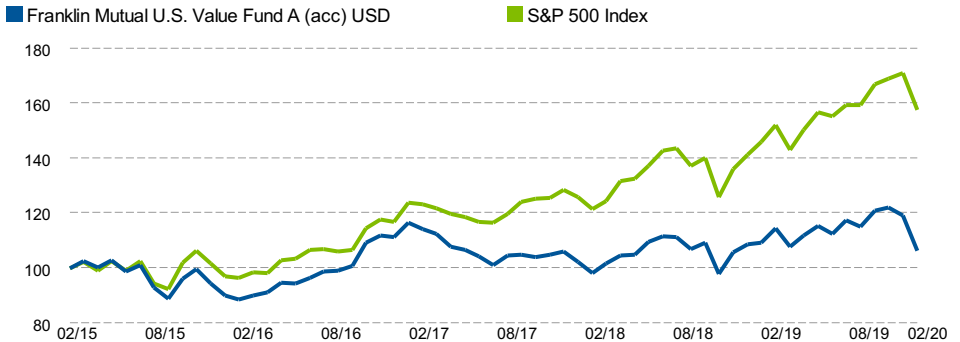
