What is this product?

Type

The product is a share class of the sub-fund Templeton Global Climate Change Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek long-term investment growth, mainly through growth of capital, while contributing to climate change mitigation and adaptation. The Fund aims to contribute to the Paris Climate Agreement's long-term global warming target of 1.5 degrees primarily through investments in solutions to reduce greenhouse gas (GHG) emissions, and secondarily through investments in companies aligning their business with this low carbon scenario.

Investment Policy

The Fund mainly invests in equities of companies that provide solutions for the mitigation and/or adaptation of climate change risk and companies which are in the process of making their business models more resilient to longterm risks presented by climate change and resource depletion.

To a lesser extent, the Fund may invest in convertible securities or debt securities.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs.

Sustainable investing The investment manager applies a proprietary rating methodology using various ESG criteria in pursuing its sustainability objective. The Fund analyses the sustainability characteristics of company business models and favours companies that may benefit from a transition to a low-carbon economy, as well as those that are good stewards of their impact on environmental and social development. The Fund also excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, gambling and weapons. The investment manager engages in dialogue with companies concerning ESG issues.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

For this share class, the manager intends to apply a NAV hedge "(Hedged)" which intends to minimize fluctuations between the base currency of the fund and the share class currency.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates). What are the costs?

Costs over Time
