What is this product?

Type

The product is a share class of the sub-fund Templeton Sustainable Global Bond (Euro) Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek to maximise income and growth of capital (total return), including currency gains.

Investment Policy

The Fund mainly invests in government bonds issued anywhere in the world and denominated in, or hedged to, EUR. The Fund may invest significantly in Mainland China. Some of these investments may be below investment grade.

To a lesser extent, the Fund may invest in corporate bonds, convertible securities and securities in default. The Fund may also hold a significant amount of bank deposits, money market instruments or money market Funds.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations).

The investment manager applies a proprietary rating methodology using various ESG criteria to assess long-term opportunities and risks. The Fund favours issuers with a high or improving profile and refrains from investing in issuers deemed among the poorest performers under certain sustainability metrics. The Fund excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, weapons and tobacco.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Buying and selling shares

You may normally buy or sell shares on any day banks are open for business in the United Kingdom.

Intended retail investor

Investors who understand the risks of the Fund and plan to invest for at least 3 years. The Fund may appeal to investors who:

- are looking for a combination of income and investment growth
- are interested in exposure to global bond markets as part of a diversified portfolio
- have a medium risk profile and can tolerate moderate short-term changes in the share price

Terms to understand

bonds, below investment grade: Bonds represent an obligation to repay a debt, along with interest. Below investment grade bonds generally pay higher interest rates but are considered less likely to make all scheduled payments or repay the initial debt.

derivatives: Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

emerging markets: Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

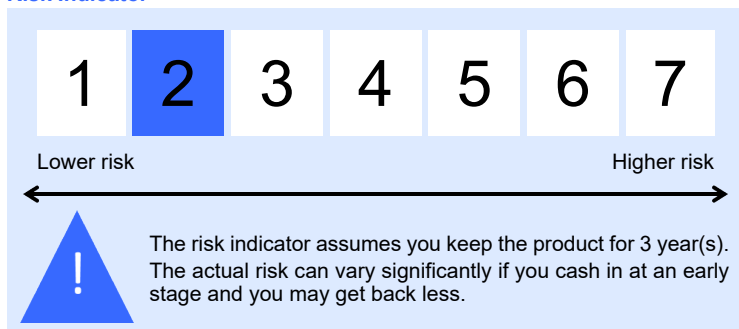

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10 000 is invested
