Objectives and Investment Policy

Templeton Global Climate Change Fund (the "Fund") aims to increase the value of its investments over the medium to long term. The Fund's climate change objective is to take participation in companies that aim to reduce emissions, improve resource efficiency and limit the physical consequences of climate change.

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity securities issued by companies located in any country which provide solutions to mitigate and adapt to climate change and making their businesses resilient to the long-term financial risks and opportunities presented by climate change and resource depletion across all sectors, and are, therefore, better prepared for a transition to a low carbon economy.

The Fund can invest to a lesser extent in:

- units of other mutual funds and exchange traded funds (limited to 10% of assets)
- cash or money market securities, convertible securities or debt securities
- derivatives for hedging, efficient portfolio management and investment purposes

The investment team uses in-depth analysis to select individual equity securities of companies with favourable environmental, social and governance attributes that it believes are undervalued and will provide the best opportunities for increased value over the long term.

You may request the sale of your shares on any Luxembourg business day. For the distribution share class shown in this document, dividend income is distributed to shareholders.

Terms to Understand

Equity securities: Securities that represent an ownership stake in a company.


Money market securities: Short-term loans (typically of less than 397 days) made to their issuers by the purchasers of the security.

Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Why is the Fund in this specific category?

The Fund invests mainly in equity securities of companies around the world. Such securities have historically been subject to significant price movements

that may occur suddenly due to market or company-specific factors. As a result, the performance of the Fund can fluctuate significantly over relatively short time periods.

Risks materially relevant not adequately captured by the indicator:

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.


