Objectives and Investment Policy

Franklin Emerging Markets Debt Opportunities Hard Currency Fund (the "Fund") aims to achieve income yield and increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- debt securities rated as B minus or above by Standard & Poor's, issued by governments, government-related entities and corporations located in emerging markets and denominated in currencies of developed economies including but not limited to EUR, GBP, USD, JPY and CHF.

The Fund can invest to a lesser extent in:

- money market instruments
- structured products and credit-linked notes
- derivatives for hedging and/or efficient portfolio management purposes such as currency forwards, interest rate swaps, future contracts and options, which are used to hedge currency exposures but also to hedge against interest rate risk

The Fund may hold on an ancillary basis equity securities which represent proceeds from restructuring or bankruptcy or as a result of a refinancing transaction.

You may request the sale of your shares on any Luxembourg business day.

For the distribution share class shown in this document, dividend income is distributed to shareholders.

Terms to Understand

Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

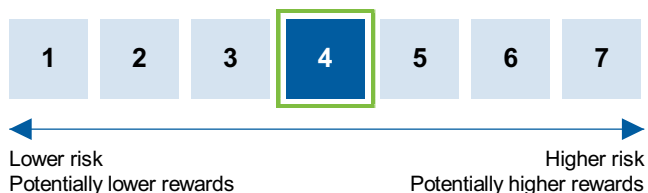
Emerging markets: Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Structured products: Packaged financial products whose value is generally linked to underlying asset(s) that are typically created to satisfy a need that cannot be met by investing solely in standard financial instruments available in the market.

Why is the Fund in this specific category?

The Fund seeks to achieve its investment objective by investing primarily in a diversified portfolio of debt securities. These securities will be denominated in hard currencies. Such securities have historically been subject to price movements, generally due to interest rates, market factors or movements in the bond market. As a result, the performance of the Fund can fluctuate over time.

Risks materially relevant not adequately captured by the indicator:

Counterparty risk: the risk of failure of financial institutions or agents (when serving as a counterparty to financial contracts) to perform their obligations, whether due to insolvency, bankruptcy or other causes.

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Derivatives risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Emerging markets risk: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

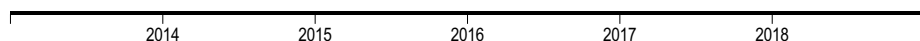
