Objectives and Investment Policy

Franklin Innovation Fund (the "Fund") aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity securities issued by companies of any size and located anywhere in the world, that are leaders in innovation, take advantage of new technologies and benefit from new industry conditions

The Fund may from time to time hold a significant amount of cash or cash equivalent where the manager believes that the markets or economic conditions are unfavourable for investors.

The Fund can invest to a lesser extent in:

- money market instruments, short-term US government securities, high-grade commercial paper and/or bank obligations
- units of other mutual funds and exchange-traded funds (limited to 5% of assets)

The innovation-focused portfolio may emphasize sectors such as, for example, information technology (including software and internet), communications

services and health care (including biotechnology). The investment team focuses on companies meeting its criteria of sustainable growth driven by innovation. The Fund may have a substantial part of its portfolio invested in companies located or traded in the US.

The benchmark of the Fund is the Russell 1000 Growth Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

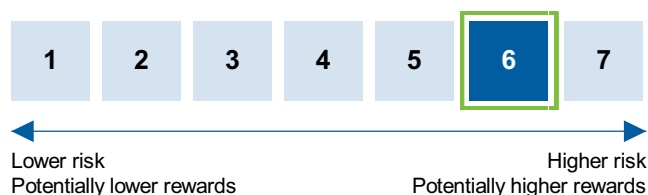

Why is the Fund in this specific category?

The Fund invests mainly in equity securities of companies that are leaders of innovation, in the estimation of the manager. Such securities have historically been subject to significant price movements that may occur suddenly due to market or company-specific factors. As a result, the performance of the Fund can fluctuate significantly over relatively short time periods.

Risks materially relevant not adequately captured by the indicator:

Concentration risk: the risk that arises when a fund invests in relatively few holdings, few sectors or a restricted geographic area. Performance may be more volatile than a fund with a greater number of securities.

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Equity risk: prices of equities may be affected by factors such as economic, political, market, and issuer-specific changes. Such changes may adversely affect the value of the equities regardless of company-specific performance.
